2017 Family Camp Campership Application Instructions

Thank you for your interest in joining us at Oakland Feather River Camp this summer! Please see below for detailed instructions on how to apply for a Family Camp Campership (Camp-Scholarship).

1. Fill out the attached Family Camp Campership Application. Make sure to tally up how much the full cost of camp will cost based on your family size and the number of nights you wish to stay. Please also make sure to note how much you can contribute toward the total cost.
2. Along with your Campership Application, please send documentation of your financial circumstances (such as a copy of IRS forms or 2 recent paystubs).
3. Please also include a 1-page letter explaining:
 - a. your need for a campership,
 - b. why you want to attend family camp this summer,
 - c. your prior experience with Oakland Feather River Camp if any (specifically what impact did the experience have on your family),
 - d. any other information that may be relevant to your application.
4. Applications must be submitted and completed prior to May 1, 2017. Any campership applications received after that date will only be considered if there are funds remaining.
5. After receipt of your family's application, financial documentation and request letter, staff will confirm receipt with you and let you know that we have received your application materials. All information will be held in confidence with office staff and will not be shared.
6. Office staff will review your materials and determine the level of financial aid granted to your family, if any. Camperships are determined on need and typically do not exceed 75% off the total cost.
7. Office staff will contact you about your campership request and the level of funds granted. We will do our best to respond to you promptly (within three weeks) after your request, however the availability of funds sometimes prevents us from doing so.
8. Upon receipt of news that your family has received a campership, a deposit of 25% of your revised total camp fees will be due to reserve your family's spot at Family Camp.
9. The remaining balance is due by June 1. If this is unreasonable, please contact the camp office.
10. Campership funds are made possible by generous contributions from our campers, donors, local businesses and supporters. Campership recipients will be asked to write a short anonymous thank you letter or card to donors who made financial contributions to make the campership possible. We will request this note to be completed during the camp experience prior to check-out.
