TENT/CABIN GROUP REQUEST POLICY

Campers are placed in tent and cabin groups by age/grade in school and by gender. Group assignments are made within the three weeks prior to camp or when all spots have been filled. Families may request up to two campers to be in the same group as their child, with the children being within one year of age of each other. We will do our very best to honor all tent-mate requests, but due to other family's requests, age and grade breakdowns and dates of registration, we cannot 100% guarantee that all group requests will be granted. Cancellation Policy: Cancellations and refunds must be requested in writing. Campers requesting full refunds prior to 21 days before the first day of Youth Camp will receive a full refund, minus a \$50.00 administrative fee. If your initial payment was made on a credit card, an additional 3% will be charged on any cancellations. Due to the short camp season, we are not able to refund camper registration fees 21 days or less prior to the first day of Youth Camp.

Bus Transportation: Supervised round-trip transportation to and from camp are included in program fees. Bus stop location will be provided well in advance of camp dates, but will be in Oakland. Please let us know as soon as possible if you will be providing your own transportation to or from camp.
